

Quarterly Disclosure Statement for 1 January 2013 - 31 December 2013 Gareth Morgan KiwiSaver Scheme Conservative Fund

What is the purpose of this statement?

This statement provides key information about the Gareth Morgan KiwiSaver Scheme Conservative Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Conservative Fund has up to 20% in shares with the balance invested in cash and fixed interest assets. The objective is to exceed the returns you would receive from investing 85% of your money in New Zealand fixed interest assets and 15% in global shares.

The Conservative Fund is referred to as the "Conservative investment portfolio" in the Gareth Morgan KiwiSaver Scheme investment statement and prospectus.

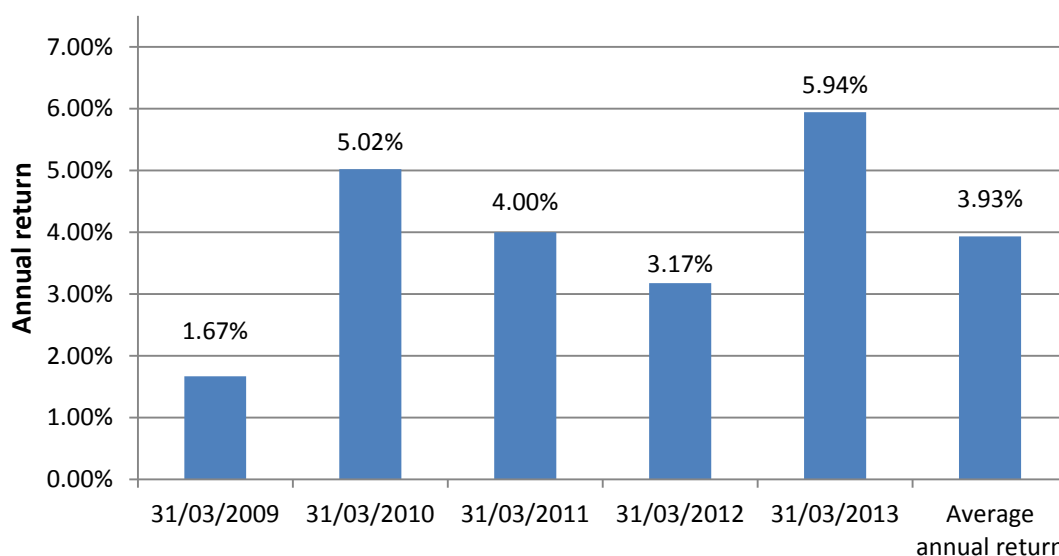

How has the fund performed in the past?

This shows the return after fund fees and tax for each tax year since the fund started and the average annual return since the fund started. It's important to note that this doesn't tell you how the fund will perform in the future.



What fees were members charged?

The returns above are after deductions for **fund fees**². These fees were last totalled up for the year to 31 March 2013 and were:

Members were also charged **membership fees**³ of **\$0** over the year to 31 March 2013.

The annual management fee is referred to as the "annual member fee" in the Gareth Morgan KiwiSaver Scheme investment statement and prospectus. The annual member fee each member pays is subject to a minimum fee of \$50 per annum. Therefore, the actual member fee charged as a percentage of the member account balance for some members may be higher than that stated in the Gareth Morgan KiwiSaver Scheme investment statement and prospectus.

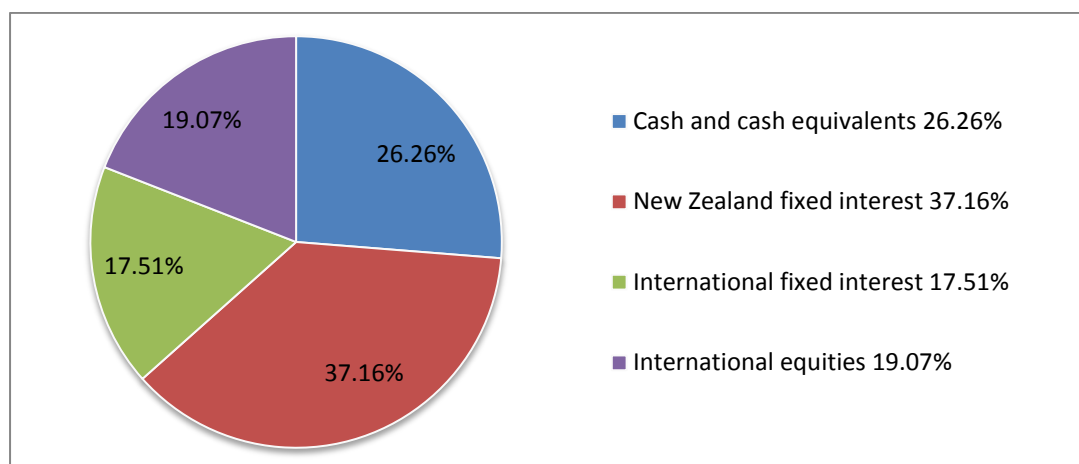
Example of how this applies to a member

Kurt had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Kurt received a return after fund fees and tax were deducted of \$588 (that's 5.88% of his initial \$10,000). Kurt also paid \$0.00 in membership fees. This gives Kurt a total return of \$588 for the year.
